Saturday 6 Nov : Award presentation and celebration 6.00pm

Sunday 14 Nov : Artworks must be collected between 4.00-6.00pm

CONDITIONS

- Artists may enter up to 4 artworks with a non-refundable \$10.00 fee.
- All artworks are to be unframed and not exceed the value of \$150.00.
- Artworks must be ready to hang; stretched canvas and canvas boards must have hanging wire on back.
- Artists may exhibit their work with mount board, cardboard or paper.
- Artworks previously exhibited in this exhibition will not be accepted.
- All artworks must be for sale to the public.
- Insurance for the artworks is the responsibility of the artists.
- Submissions of various mediums are welcome (jewellery, textiles, etc) however, the organizers reserve the right to veto works.
- Artists are required to assist with the installation of their artworks.
- Velcro, pins, tape and various adhesives may be used in the installation of the artworks.
- The judges decision on the selection of the award is final and no correspondence will be entered into.
- 2D artworks exceeding 1.0m and sculptural works larger than 1 cubic metre are to be approved by the organizers.
- A commission of 25% will be deducted from all sales, with the proceeds paid to the artists within 21 days of the close of the exhibition.
- Works entered may be reproduced by print and electronic media for the catalogue and publicity purposes.
- All 2D and 3D artworks to be clearly labelled with; Artists name, address, contact number, title of work , medium and price.
- Artists may be required to be on the artist roster and to assist with minding the exhibition.
- By entering the artists agree to the conditions of the exhibition.
- Artwork must be the entrants original work.
- Indigo Residential Artists given preference.
